There are NO Dark Launch features during this release.

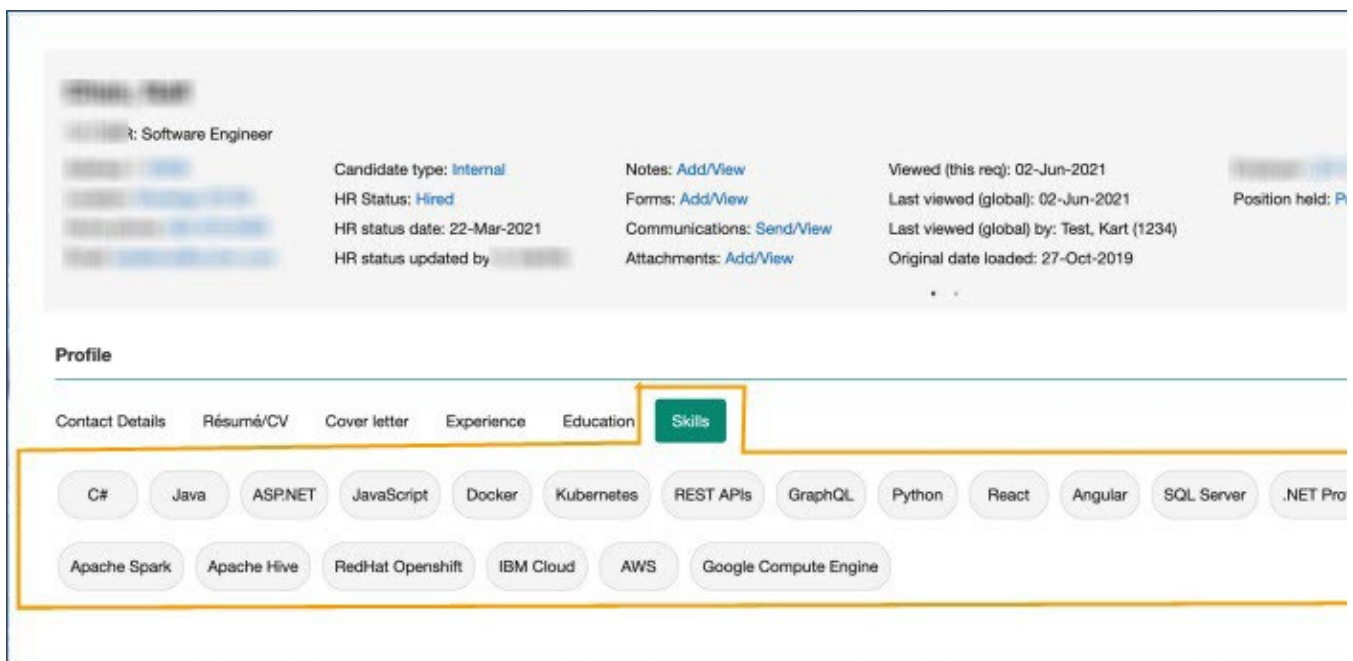
Visible Changes

The current release of SIGNAL LABS® Kenexa® BrassRing ATS® on Cloud includes the following visible changes for BrassRing ATS and SIGNAL LABS Kenexa BrassRing Lead Manager.

Candidate Anonymization - Candidate Skills

Unconscious bias is an enormous challenge for clients - recruiters might take decisions that are based on a person's name, hiring managers might hire people that attended certain schools. Although the bias cannot completely be removed, certain steps can be taken to help reduce the unconscious bias. To help clients overcome the unconscious bias, a new feature is added starting this release. The skills of the candidates are provided for review to BrassRing ATS users in various screens.

Agency Manager - Candidate Privacy Screen Changes

The Agency Manager Candidate privacy policy confirmation screen previously has an **OK** button, which did not have an appropriate action upon user selection. Candidates reach the privacy policy page and select Agree or Disagree to the client's privacy policy by selection respective buttons. To avoid ambiguity, the **OK** is removed during this build.

Configurable Changes

The current release of SIGNAL LABS Kenexa BrassRing ATS on Cloud includes the following configurable features for BrassRing ATS and SIGNAL LABS Kenexa BrassRing Lead Manager. Configurable features must be configured or turned on to be visible and available to users.

Talent Gateways - Skip Sign-on - Account Creation Option

Based on client request, for candidates that skip the sign-on when they apply for a job, a new option is provided to create a Talent Gateway account. Candidates receive email communication that contains a hyperlink **Create Account**. Candidates select this hyperlink to open a Talent Gateway account creation page.

To provide this new account creation option, a new merge token is added in the candidate communications in BrassRing ATS. BrassRing ATS administrators can create a communication template or edit the existing communications template to add the new merge token **[#Candidatezone:CreateAccountSkipSignOnURL#]** to the template. When administrators preview this template, the merge token is rendered as **Create Account**.

When candidates create an account by using this hyperlink, the Candidate Dashboard (Candidate Zone > Dashboard) is displayed. Candidates can find the jobs that they applied to in "skip sign in" flow in this screen.

Note: This merge token generates an account creation hyperlink only if the candidate's Talent Gateway data specific to the Skip Sign-on submission is present. Therefore, clients are advised to frame a clear message around this token in the email that is intuitive to say when do candidates see a link. Example text: *If you skipped account creation or signing-in while you submitted application, you find a link below to create an account that is tied to that submission. Otherwise, no link is shown.*

Talent Gateway - Minimum Password Length

Based on a new Workbench Configuration, clients can set up a minimum length for candidate profile login password. No change in the way candidates log-in if the client does not change the default configuration of minimum 8 characters. However, if a client updates the minimum length, the new minimum length configuration is enforced in the following scenarios:

- Candidates create a new Talent Gateway profile.
- Candidates change their existing password.
- Candidates' Password Reset (due to expiry).

An alert message is displayed next to the password field: **Must be X-25 characters** (where "X" is replaced with configured minimum value). The Password tips modal that displays a list of tips for setting up a password has a similar alert message as the first item of the list: **Must be X-25 characters** (where "X" is replaced with configured minimum value). When candidates provide a password, if the password length is less than the configured minimum length, an error message is displayed stating: **Password - Must be X-25 characters** (where "X" is replaced with configured minimum value).

BrassRing ATS Workbench

The current release of SIGNAL LABS Kenexa BrassRing ATS on Cloud has the following new features for SIGNAL LABS Kenexa BrassRing ATS Workbench. Configurable features must be configured or turned on to be visible and available to users.

Partner XML Synchronization Utility - Performance Improvement

Starting this release, the Partner XML synchronization utility is updated. Based on the new updates, the tool does not automatically synchronize any inactive Talent Gateways. Therefore, the tool automatically synchronizes active Talent Gateways only. However, workbench users can manually synchronize the inactive Talent Gateways.

Talent Gateway - Password Length Configuration

Starting this release, clients can configure the minimum length of the password for Talent Gateway candidate profile login. A new field is added in the Responsive Layout Details screen for configuration.

Minimum password length is added with a field that allows only integers in the range 8 - 25. The default minimum length of password remains to be 8 characters and can be configured up to 25 characters. If user enters any value other than an integer in the range 8 - 25 (both inclusive), the message **Minimum password length must be a number between 8 and 25** is displayed.

Rules Automation Manager (RAM) - Lead email Option

Previously, when Workbench administrators configured a RAM trigger to send a communication based on a status update, no option was available to select the Lead as the recipient. Starting this release, a new option is introduced to add the Lead's email.

In the scale select list of recipients, a new option for Lead email - **[BrassRing Lead Manager] Lead email** is added. This option is available only for the RAM triggers that are created for BrassRing Lead Manager and for clients that enabled BrassRing Lead Manager. Currently, only two trigger mechanisms that have Lead in the context are available:

- Lead Creation
- Lead Campaign Status.

Visible Changes

Visible changes alter the appearance or performance of the product without requiring any configuration. The changes are immediately visible or available to users.

I9 Audit Trail - Investigations

The following issues in the I9 audit report were resolved during the current release:

- Previously, when I9 documents were updated, the background data was being duplicated. When a user updates a document, the document's data was being removed and updated in the database. At this point, two rows of data was being added instead of one. Starting this release, the duplication of rows is addressed and only one row of data is created when the documents are updated.

I9 Approver Task Screen - Internal/External Approver Field Enhancement

Starting this release, the following enhancements are made to the External/Internal approver field:

- The Internal/External approver field in the I9 Approver Task screen previously was not allowing special characters '@' (At sign) and ',' (comma). Starting this release, the following special characters are allowed in the Internal/External approver field:

- At sign - '@'
- Comma - ','
- Space - ' '
- Underscore - '_'

Users can now use these special characters to search for approver names in the suggestion box.

- Previously, when users entered three or more letters in the suggestion box, the closest suggestion was automatically selected in the field. When additional letters are added by the user, the letters are appended after the selection. Starting this release, to improve user experience, approver names are not automatically selected. Instead, the list of all names that are suggested are displayed in the drop-down box. Users can either make a selection from the displayed list, or continue to enter more letters/special characters to get better suggestions.
- Previously, only the Control+V combination of keys was allowed in this field. Starting this release, the following key combinations are allowed:
 - Control +V
 - Command + V
 - Mouse Right click + paste
