BrassRing New User experience is currently available in the staging environment. We are enhancing this new experience based on the feedback we received from you. Please contact your Infinite representative or the GSC to know more about this exciting new user experience and let us know what can be done to improve it further.

BrassRing Dark Launch

Dark Launch features are those features that are released to the Staging environment only and are NOT released to the Production environment for a considerable amount of time.

This process gives an opportunity and enough time to test these features thoroughly before they are available in the production environment. Clients are requested to configure and test these features and provide their feedback and inputs to your respective Infinite representatives.

There are no Dark Launch features in this release.

BrassRing Visible Changes

The BrassRing visible changes for the current release are listed here.

BrassRing - New User Experience

This change is a part of the BrassRing New User Experience that is currently available only in the Staging environment.

Starting this release, the 'Profile' tab in the candidate Talent Record page is locked and prevents users from removing it from the selected columns.

By locking the 'Profile' tab in the candidate Talent Record page, users are not able to remove it from the selected columns. Even if users don't have privileges for any other tabs in the candidate Talent Record page, the 'Profile' tab remains visible by default.

Talent Gateway - Delay HR Status Update

A delay can be configured between when a final HR Status update in BrassRing happens and when it is going to be visible on the Application Details page in a candidate's Talent Gateway profile.

Currently, this feature is available only for Final HR status categories.

Starting this release, a delay is applied for the initial HR Status of the candidate (when there is no previous HR Status) and the first HR Status Category is displayed if there is any delay applicable to the candidate's HR Status.

BrassRing Configurable Changes

The BrassRing configurable changes for the current release are listed here.

Talent Gateways - Cookie Consent

Starting this release, a cookie consent banner is displayed at the end of the Talent Gateway page based on Workbench configuration.

The banner is displayed until the candidate selects **Ok, got it**. It appears throughout the session irrespective of any action being performed on the Talent Gateway until the candidates select **Ok, got it**.

This is session specific, and upon opening a new session **Ok, got it** appears again.

When a candidate selects **More Information** , the Privacy Preference Center window appears with details of the Cookie Policy.

BrassRing Workbench Changes

The Workbench changes for the current release are listed here.

Talent Gateways - Cookie Consent

Starting this release, a cookie consent banner is displayed at the end of the Talent Gateway screen if configured in the Workbench.


Workbench Path:

Tools > Talent Gateways > [Select Talent Gateway] > Responsive layout > General > Cookie Consent.

Upon checking the Show Cookie Consent, the Cookie message text area is enabled.

This is a Global level setting and it reflects in all the members of the Global Talent Gateway.

This text area has a default message. The message can be customized based on the client's requirement in the desired locale and it can include links.

Once the cookie consent setting is enabled in Workbench for a Talent Gateway, the configured message is displayed as a banner at the end of the Talent Gateway screen when launched.

The banner's branding matches Talent Gateway's home page. It includes "More Information" and "Ok, got it" buttons.

The banner remains visible in the logged-in session until the candidate selects "**Ok, got** it".

This is session specific, and upon opening a new session the **Ok, got it** button appears again.

Upon clicking the "**More Information**" button the "Privacy Preference Center" window is displayed with all the cookie information details.



NOTE

The Talent Gateway consent feature is not applicable to Talent Gateways that have Talent Suite Authentication enabled.




